Notes:

1. The top **three** spaces for each fiscal years 1996-97 through 2002-03 were the most recently elected Directors serving during those periods (**green**). Thereafter, the top **four** spaces are for the most recently elected Directors (**green**). The second three/four spaces have two-year terms remaining (**red**) and the last three/four spaces one-year remaining term (**blue**).
2. Read the squares diagonally, moving like a checkerboard, from top left to bottom right.
3. All terms begin October 1st and run through September 30th of the following year as designated.
4. The first and second years of OKKPA required a drawing of 3 names to serve for one year and 3 names to serve for two years. This allowed OKKPA to stagger the 3-year terms of original Board of Directors.
5. *Elections for directors to replace those with 3-year terms ending.
6. ** **Appointed** to fill unexpired terms of those at-large directors who were elected to serve as officers or who vacated an office or at-large directorship.
7. *** Bylaws were amended in 2003 to increase the number of at-large directors from 9 to 12.
8. ****Bylaws were amended in 2016 to limit Directors to two consecutive terms.
9. 2018-2019* By-Laws amended for Directors to several full calendar year and change on January 1, 2020. (2016-2019 Directors term extended to January 1, 2020)
10. 2021 By Laws amended to reduce the number of Directors at large from 12 to 6. Larry Young, Max Ostner Jr., Chip Benson and Allen Vanlandingham stepped down as of 12/31/2021
11. 2021 Bylaws amended to eliminate term limits
12. 2021 Bylaws amended to eliminate Corresponding Secretary position

September 2021 the office of Corresponding Secretary was eliminated by amendment of the Bylaws, effective 1/1/2022.
